By the end of 2010, we had sterilized more than 3,316 cats. Dr. Tom Chlebeczek and Dr. Vladimir Jurek (above) traveled from the Czech Republic in November to help Maui's kitties. Dr. Tom returned with Dr. Martin Kares and Dr. Pavlina Kares in February 2011. This February, 6 day, Spay/Neuter clinic is ongoing as of this newsletter.

We want to thank the Pacific Whale Foundation for providing a snorkel cruise for the vets in November and Olapa Ko'a Charters for trips on The Reef Dancer and America II. These vets travel from halfway around the globe to help Maui's kitties. You can share aloha by donating gift certificates for tourist activities for their days off. They love ocean activities, enjoying our multi-national cuisine and the usual activities that Maui's tourists enjoy and they will be returning during the Spring to hold another mass clinic.

GOAL FOR 2011

Our goal for 2011 is to have sterilized 5,000 cats by the end of the year. We can only do that with your help. We are focusing on multi-day clinics, with several vets attending to maximize the number of cats sterilized. Each multi-day clinic in which hundreds of cats are sterilized runs us about \$7,500.00. 9th Life always needs cat carriers, cat traps, cat condos and cat toys. We also need a van for transporting cats to and from our huge, Spay/Neuter clinics. (Tax deductible donation for you.)

Many of you already know that we lend out cat carriers and traps for our Spay/Neuter clinics. A large percentage of the people we help do not have the funds to purchase carriers or traps and this of course means they have no way of getting the cats to our clinics.

If you have traps and carriers (dog or cat) that you no longer need, please donate them to 9th Life. We also provide carriers to people leaving Maui who can't afford the expense of taking their cats with them.

CAN YOU HELP WITH CAT FOOD AND KITTY LITTER?

Our cat food costs run about \$1,000.00 per month. Most of our cat food is purchased at Costco, Wal-Mart and K-Mart. If you want to donate gift cards for these stores, we will use them to purchase cat food and kitty litter.

COULD YOU USE A BARN CAT, BUT DON'T HAVE A BARN?

On the mainland they call them barn cats. Some call them feral. We prefer to call them community cats. Most will not want to be petted, but we believe they have a right to live. They have been used for centuries to patrol granaries, silos, food storage areas and do an admirable job of keeping rats and mice and bugs under control. One New York City Police station even uses them to control mice and rats in their basement storage facility.

9th Life has some barn cats to place. They are not lap kitties although we have plenty of those available for adoption also. They need food, water and a warm, safe place to sleep. If you are interested in making a home for a community cat and will provide food, water and covered shelter for these cats, we want to hear from you.

NO KILL IS A NO BRAINER

No Kill facilities are saving lives worldwide. Municipal, open admission shelters that had 80%-90% kill rates are now boasting 90% **save** rates. The nation of New Zealand is working towards being the first No Kill nation. When New Zealand embraced NO KILL, some of their facilities had an 87% kill rate but now are averaging an 80% save rate.

The No Kill equation is working and it is up to us to insist that shelter directors leave no stone unturned in saving lives. For the Nay-Sayers that say it cannot happen here because the community is irresponsible or it can't happen because we are an open admission shelter, we say: Read the success stories. Implement the No Kill Equation now.

If a shelter director is not implementing NO KILL they are not leading Humane Societies, but are leading **IN**humane Societies and it's time for a change of leadership. 9th Life's mission is to educate and lead a better way, a humane way to treat animals and we thank our supporters who help us lead the No Kill Movement in Hawaii.

We sent out a PSA. The owner did not respond and the dog was brought down to the Maui Humane Society (photo above). Using email notices, we searched for a foster home. Lesllie offered to foster him and post photos on Craig's List. Weeks later, the owner (an 11 year old boy) saw the posting and reclaimed his dog. It was a happy reunion the result of networking and using the internet for good.

How often have you heard Maui called paradise? We love it here, but realize there is some degree or measure to the happiness of our island home. Would the animals that live on Maui call it paradise? For many of them, it is far from it, such as the thousands and thousands of animals that are killed every year at the Maui Humane Society.

How about the horses who are subjected to unyielding sun, wind and rain for days and weeks without shelter? The dog on a short chain 24 hours day? Then there are the roosters & dogs forced into brutal combat with their own for the amusement of the depraved.

Just this week the Maui News reported four men in Iao Valley State Park torturing and killing feral cats with bow and arrow, a felony charge of animal cruelty (details below). Think this was paradise for those cats or their colony caretakers?

Hawaii consistently ranks in the bottom 10% of the states for laws concerning animal welfare, and is generally in last place for laws against dog fighting. There are two companion bills in the Hawaii State Legislature this session scheduled for hearings week of 2/21/11 (HB108 and SB1069) which could help to change that.

We are setting up a special 9th Life email group for people who want to be actively involved in the legislative process with regard to animal welfare laws. We will advise of pending legislation and invite you to decide for yourself if you want to be pro-active. If so, please let us know via email to 9thlifelifehawaii@earthlink.net

Maui County laws are generally highly regarded for our animals, being much stronger than our State's, but they need to be enforced or they become meaningless. Just like humans, some animals live a more idyllic lifestyle than others.

Although the hundreds of kitties at 9th Life are well-cared for, most still want their own (human) family with whom they could closely bond.
